Polaris® Name Your Cleaner Sweepstakes
Official Rules

1. **ELIGIBILITY:** The Polaris Name Your Cleaner Sweepstakes (the “Sweepstakes”) is open to any individual who owns a Polaris pool cleaner and **is not** a licensed or practicing pool or spa professional working in the swimming pool industry (residential and/or commercial retailers, service technicians, builders and/or remodelers) who is a legal resident of, and physically located within, the fifty (50) United States or the District of Columbia and who is eighteen (18) years or older as of **August 30, 2019**. Employees of Zodiac Pool Systems LLC, any of its parents, subsidiaries, affiliates, advertising and promotion agencies and their family/household members (“household members” includes, parent, spouse, children, and/or siblings), or of any company affiliated with the Sweepstakes and collectively with the foregoing person or entities, are not eligible to enter.
